UPON ARRIVAL, GUESTS HAVE ACCESS TO AMENITIES SUCH AS TRANSPORTATION TO AND FROM THE HOSPITAL, A FULL KITCHEN AND DINING ROOM WITH SOME MEALS PROVIDED BY VOLUNTEER GROUPS, A LAUNDRY ROOM, WIRELESS INTERNET, AND FELLOWSHIP WITH OTHER GUESTS OR FULL PRIVACY. THE EDUCATION PROGRAM ENCOURAGES GUESTS TO SHARE THEIR EXPERIENCE WITH A MEDICAL CRISIS.
